Abstract	Wilhelmina Rolark served on the Superior Courts of D.C., and served as chair of the City Councils Fiduciary Committee and the Advisory Committee on Probate and Fiduciary Rules. Rolark founded the National Association of Black Women Attorneys. Rolark worked with area black-owned businesses when many faced difficult legal or financial problems. She worked with her husband to develop the United Black Fund to help non-profit organization take advantage of philanthropists in the city. Her papers consist of subject files, meeting files, government documents, event files, certificates, diplomas, awards, and photographs that document her extensive career.

Biographical/Historical note

Scope and Contents note

The Wilhelmina Rolark papers date from 1882 to 2002, the bulk of which date from 1980 to 1992 and document Rolark's career in law and D.C. politics. Subject files consist of research files, documents, reports, briefings, and other background materials. Notable subjects include city council, bail reform, judiciary committee meeting materials, and various news clippings. Meeting files document Rolark's tenure on the committee on the judiciary and include meeting minutes, briefings, notes from town meetings, and files from roundtable discussions. Government documents include copies of and notes on bills, including the D.C. Child Support Enforcement Act, the Public Defender Service Amendment Act, HR 1629 District of Columbia Statehood Constitution for State of New Columbia, the Public Safety Employees Anti-Discrimination in Conditions of Employment Act, and notes from an oversight hearing on AIDS Policies in the Department of Corrections. Event files include memorabilia and photographs from events that Rolark took part in, including a video from Martin Luther King, Jr. Day in Southeast D.C. and a photograph from Malcolm X Day. Certificates, diplomas, and awards includes accolades Rolark recieved from various service organizations including the National Association of Black Women Attorneys, the National Bar Association, and Ward 8 Democrats, among other groups. Photographs include Rolark's family photographs, as well as photos with key political figures such as Jesse Jackson and President Carter.
