Dear Sir,

I beg to advise you that, because of the unusual large number of contests with which we are threatened at this time, it is probable that the Republican National committee will be called upon to meet this year at a date much further in advance of the assembling of the convention than is usual. It is likely that this date will be as early as the first of June, and this note is meant to prepare you for this emergency should it arrive. I have fully determined, in view of the peculiar circumstances attendant upon the contest for the presidential nomination this year, that all contests shall be heard by the full membership of the National committee. There will be no sub-committees under any conditions, and, this being true, the time spent in settlement of contests will be necessarily long.

This is not an official notice but is merely intended for your information in order that you may make preparations to be in Chicago as early as the first of June if it is found necessary to assemble the committee at
