A welcome address was delivered by Dr. W. Harry Bear, Dean of the School of Dentistry of the Medical College of Virginia. Dean Russell A. Dixon of the College of Dentistry of Howard University responded to the address. The moments of interest proceeded from this beginning thru two days of instructive clinics, which were presented by members of the faculty of the School of Dentistry of the Medical College of Virginia.
