GLEANINGS FROM OUR ALUMNI

1899

Dr. C. C. Fry has been retired by the D. C. Health Department after many years of meritorious service.

1907

Dr. Albert O. Reid was born in Gatesville, North Carolina, and received his early education

in the public schools of his native town and later at Hampton Institute, from which he was graduated in 1903.

During the winter of 1903-1904 he served as principal of a public school at Murfreesboro North Carolina. In the fall of 1904 he matriculated at Howard University College of Dentistry, and in June, 1907, was awarded the D. D. S. degree as the outstanding member of his class. In January of the following year he entered into the practice of dentistry in Baltimore, Maryland, and has had unusual success in that city over the years.

During his long residence in Baltimore Dr. Reid has alligned himself with the institutions that stand for social progress. He is a member of the National Dental and National Medical Associations and their local societies, and was a charter member of the parent organization of the present National Dental Association, its treasurer, and its president.

For twenty-five years he has held the office of clerk or trustee of the Union Baptist Church. Among his other affiliations are: Membership on the Board of Directors of the Urban League and of Provident Hospital, in the Masons, and in the Knights of Pythias.

Dr. Reid has not been content to give only of his time and talent for the uplift of his race, valuable though these contributions have been, but in the field of education, especially, he has given quite generously of his money. Howard University School of Medicine received a cash contribution of \$1,000 from

him at one time. Hampton Institute, Morgan College and Tuskegee Institute have all been recipients of his benefactions from time to time.
