NATIONAL DENTAL ASSOCIATION

T HE National Dental Association will hold its Silver Anniversary Convention in Chicago on August 9, 10, 11 and 12th. This meeting marks twenty-five years of unbroken effort on the part of those in the profession who have believed firmly in the constructive possibilities in an organization of dentists, by dentists, and for dentists.

The meeting last year in Washington, D. C., at Howard University surpassed in every particular all previous achievements, and we expect the coming meeting to eclipse in many ways the meeting of 1937.

These meetings from year to year must be a manifestation of a growing spirit of cooperation in the dental profession. Organized dentistry, however, has much more to offer than meetings, clinics and conventions. The Lincoln Dental Society of Chicago will be the host to the National Dental Association on this, the occasion of its Silver Jubilee. We received a letter as of March 28, 1938, from Dr. Hebert and Dr. Harmond inviting and urging those who have something worthwhile to offer for the program to submit it by June 25th. It is to be hoped that the response will be of such nature as to guarantee a program truly representative of the various geographical areas of the organizations.

President Beamon is very anxious that every old member should come to the "Windy City" and bring at least one new member with him. The goal is set for a registration of one thousand. This goal should be reached. Dr. Jackson, National Secretary-
