## Scope Note

The scrapbooks of Andrew Jackson Howard, Jr. disclose the activities of his career in the legal profession and a few of his social activities involving the community in Washington, D.C.

The two scrapbooks of news clippings that Judge Andrew Jackson maintained, document the various cases upon which he presided, and throw light on some of his social activities.

### Biographical Sketch

- 1897 Born Alcorn College, Ebenezer, Mississippi.
- 1916 Came to Washington, D.C. to attend Howard University.
- 1930 Worked for Justice Department (as messenger).  
Received L.L. from Howard School of Law.
- 1938 Married Ruth Baltimore (2nd wife).
- 1942 Appointed to the United States Attorney's Office.
- 1950 Appointed Associate Judge of the Municipal Court by President Harry S. Truman.
- 1963 Appointed to the Municipal Court by President John F. Kennedy.
