1906

1910

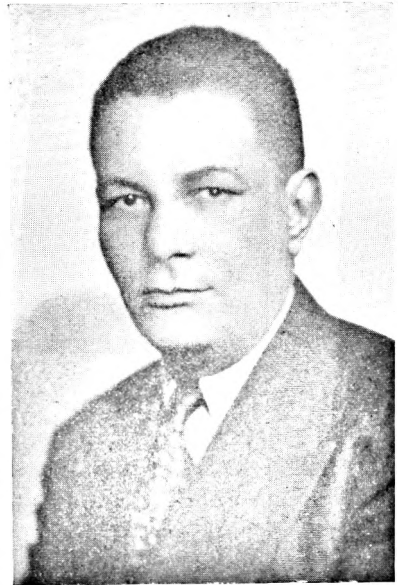

Dr. William O. Giles, the Oral Surgeon of Provident Hospital in Chicago, was honored by a group of dentists of one of the study clubs of the Lincoln Dental Society, for having instructed them in Oral Surgery. He was given a beautiful, up to date traveling bag.

1915

Dr. Raymond B. Thomas appeared before the Robert T. Freeman Dental Society of Washington, D. C., at its April meeting '41 and presented a highly instructive, illustrated talk on "Acrylics." He displayed models of several practical cases which he had constructed in his private practice.

He has worked consistently with the business interests of the city for the improvement of business in general, and now serves as Vice-Chairman of the Board of The Consolidated Bank and Trust Company, President of the University Realty Company, and Director of the Recreation Association.

His affiliations with fraternal organizations are many, and in organized dentistry among our group, his efforts are highly significant. His untiring efforts and deliberate work in the various offices in which he served in the Old Dominion, the Tri-State, and the InterState Dental Societies, helped to build the foundation for our present National Organization, in which he is yet active.

Dr. Reid holds the distinction of being a charter member of the Chi Delta Mu Fraternity and is a member of the Alpha Phi Alpha Fraternity.

He has since December, 1917 been married to Miss Minnie V. Ferguson, and out of that union have been born three children, Alice, Leon, Jr., and Feyum.

We are happy to learn that Leon, Jr., hopes to follow in Dad's footsteps, for if his "Uncle

Sam" permits, he plans to enter the College of Denistry, Howard University, this September.

As we go to press we learn with deep regret of the sudden illness of Dr. Reid, and earnestly hope for his speedy recovery.

Dr. A. C. Spence is practicing in Atlanta, Georgia. He and his wife, who is a pharmacist, operate a drug store.

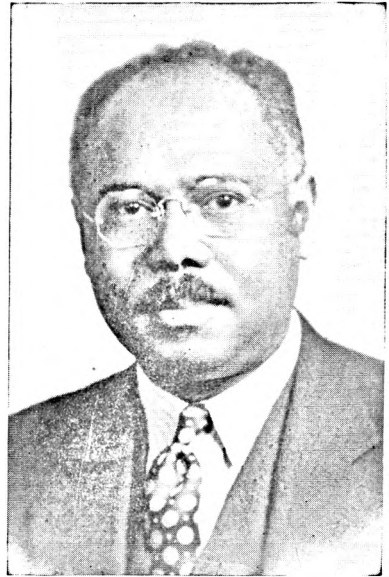
Dr. Dennis Smith, of Charleston, West Virginia, in addition to caring for a full practice, operates with the aid of his wife, a plant for making ice cream.

Dr. H. Cicero Edwards began practice in Pittsburgh, Pa., in 1924. He has been, from the beginning, an ardent worker in the ethical and moral advancement of the dental profession, as well as in civic affairs. He served as Secretary and President of the Medical, Dental and Pharmaceutical Society of Allegheny County, as well as Pennsylvania State Vice-President. During this time, Dr. Edwards contributed an article on "A Plea For Better Cooperation Between the Physicians, Dentists, and Druggists." He was organizer and President of the Allegheny Valley branch of the N. A. A. C. P., one of the

most active branches (at that time) in the state.

Dr. Edwards returned to the District of Columbia in 1932, qualified, and began the practice of Dentistry. He immediately aligned himself with the Robert T. Freeman Dental Society of the District of Columbia, the oldest organization of ethical dentists of color in the world. Shortly after his affiliation with the Robert T. Freeman, he was elected Secretary of the organization, an office which he still fills. He also is a member of the Executive Committee, Health Committee, and Speakers Bureau.

However, Dr. Edwards' activi-

ties are not confined locally, as evidenced by the fact that he is an Assistant Secretary of the National Dental Association, and Chairman of its Scholarship Committee, having previously served this organization as Chairman of its Committee on Statistics and History.

Dr. Edwards is a firm believer in the use of the ballot. He thus maintains his voting right in the Commonwealth of Pennsylvania. He is one of the organizers of the Pennsylvania State Club of the District of Columbia, and is at present Treasurer, and a member of the Executive Committee. He is a member of the East Central Civic Association of the District of Columbia; Kappa Alpha Psi Fraternity and its Housing Committee; charter member of the Chi Lambda Kappa Honorary Dental Fraternity. He represents the "cycle of fours" in Dr. Montague Cobb's Class Scholarship Fund. He is also a member of the District of Columbia unit of the Hampton Alumni; the Dunbar High School Alumni; as well as the District of Columbia branches of the N. A. A. C. P. and the Urban League.

During the last World War, Dr. Edwards served in the 368th Infantry, A. E. F., and is now the only member of color of Local Draft Board No. 25, of the District of Columbia Selective Serv-

ice, and its elected Secretary.

Dr. Edwards is married to Ethel A. Johnson, of the District of Columbia, and has one son, H. Cicero Edwards, Jr., a senior at Shaw Junior High School, Washington, D. C.

1926

Dr. Charles M. Colden is now practicing in Suffolk, Va., and uses an entire floor for his office and laboratory.

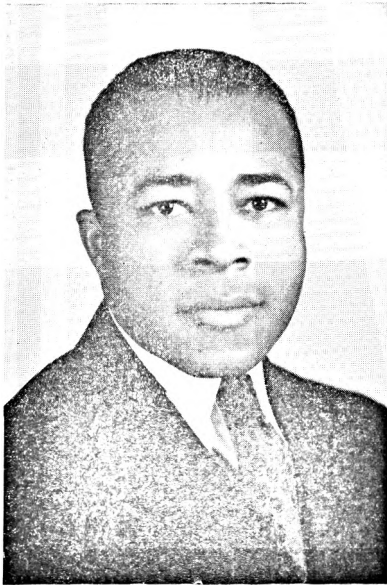
1928

Dr. J. E. Carter, of Augusta, is President of the Georgia Dental Society.

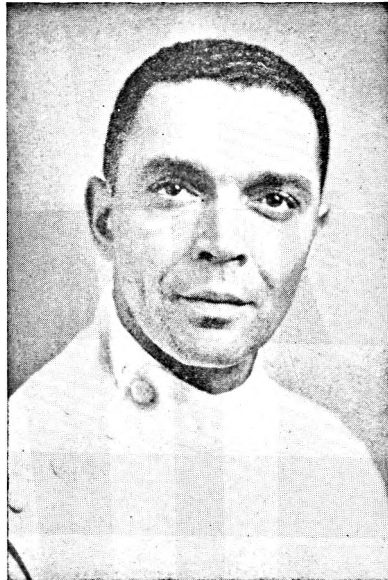
1932
