The Edward Walter Turner Collection consists of manuscript materials that document his association with the Masonic Order and the Howard University. These materials are correspondence, certificates, invitations, programs, reports, and resolutions.

There are personal items of memorabilia such as the sprig of the decoration from the stand where President Ulysses S. Grant gave his inaugural speech, and a broadside with Howard University songs. Turner also kept personal diaries of his expenditures and a diary on the historical account on the unveiling of the Lincoln Statue at Lincoln Park, Washington, D.C. on April 14, 1876.

The collection strengths are the mounted newspaper clippings from various papers that are on selected individuals, events, institutions and places. The collection does not contain a significant amount of materials that document Edward Walter Turner's life nor the activities he was involved in.

The collection dates span the period 1871-1926. The collection size is approximately ½ liner foot. The collection was received as a gift to the Howard University from Sara A. Turner.
