Biographical Sketch

After retirement in 1922, Bruce served as principal of a high school in West Virginia, as manager of the Dunbar Apartments in New York City, and engaged in various Real Estate activities.

His specific contribution to public education in Washington lay in setting the foundation for the school system as organized under the Act of 1906. Until that time, there was a Board of Education for white schools and another for Negro schools, with a separate Superintendent heading each.

Scope Note

The Roscoe Conkling Bruce, Sr. papers measure two linear feet and primarily consist of personal and holographic correspondence, spanning the years 1897 to 1924.

The family correspondence include personal correspondence between Roscoe C. Bruce, Sr. and the following members of his immediate family: his father, the former U.S. Senator Blanche K. Bruce; his mother, Josephine B. Bruce; his wife, Clara Burrill Bruce (both before and after marriage); and his son, Roscoe C. Bruce, Jr. The family correspondence cover a spectrum of personal and financial matters, such as Roscoe Bruce's service at Tuskegee Institute, tuition payments made by Blanche K. Bruce and the reaction of Roscoe Bruce to the elopement of his daughter in 1922. This family correspondence reveals intimate thoughts and feelings between the corresponding members of the family.

The general correspondence reflects Bruce's official duties as Assistant Superintendent of D.C. Public Schools. Of special note is a copy of an investigative report relating to Bruce's controversial administration as a public school official in Washington, D.C. Other important correspondents include W.E.B. DuBois and Carter G. Woodson.

The financial and legal papers deal with the management by Bruce and his mother of the Blanche K. Bruce Plantation in Mississippi and the Kelso Farm in Washington, D.C. Other real estate and insurance documents are also included. Other items of special interest are Roscoe C. Bruce Sr's drivers license and car registration, photographs, and a holographic draft of his will. There are clippings relating to Roscoe Bruce Sr's academic training and professional life, including a clipping related to Roscoe C. Bruce Jr. being barred from the freshman dormitory at Harvard in 1923 because of his color.

Printed materials include items from *The Crisis*, and *The Exonian*, dated 1897, which is a Phillip's Exeter Academy publication.
