Abstract	Youth Pride, Incorporated was founded by Carroll Harvey, Mary Treadwell and Marion Barry in 1967, and was a youth job placement program that lasted more than a decade. The Youth Pride, Inc. Records document the day-to-day business of the organization. Among the records are administrative memoranda, subject files, Board of Elections records, chronological files, financial documents, meeting files, termination reports, and the Youth Pride Voter Education Questionnaire.

Biographical/Historical note

Youth Pride, Incorporated was founded by Carroll Harvey, Mary Treadwell and Marion Barry in 1967. A youth job placement program that lasted more than a decade, Youth Pride, Inc. began as a challenge contract awarded by Willard Wirtz, who served as Secretary of Labor. In the first thirty days of the project, Youth Pride, Inc. enrolled 1,000 young men to participate in a street cleaning program. Based on the initial success of the program, Youth Pride, Inc. was awarded a one-year federal contract. Youth Pride, Inc. hired and trained young men and women to complete community improvement projects. The program eventually evolved into an endeavor that provided needed training to area youth, implemented stay-in-school initiatives, offered tutoring to at-risk students, and encouraged local students to pursue higher education. At its most effective, Youth Pride, Inc. consisted of several departments, including Continuing Education Learning Laboratory, Reinforced Learning Laboratory, Higher Education Learning Laboratory, Skills Development, and Supportive Services. Youth Pride worked to create sustainable solutions to the social and societal problems young people faced in the 1960s and 1970s. The project was designed to provide young people a means to escape the cycle of poverty and aimlessness some young people experienced living in the city. Mary Treadwell served as the Executive Director, managing the federal contract and developing policy and programming. After serving local students for 15 years, Youth Pride, Inc. closed its doors in August 1981.
