Scope Note

The papers of Attorney Matilene Spencer Berryman (1926-2003), reflect a legacy of outstanding achievements and accomplishments related to her work as an oceanographer, college professor and administrator in marine and environmental science as well as an attorney. The collection spans from 1964 to 2001, and measure twenty two cubic feet. The bulk of the papers covers the period from 1973-2000. In 2010, Moorland Spingarn Research Center acquired the collection from the estate of the late Dr. Sherrill Berryman Johnson, Berryman's eldest daughter's. Berryman's papers primarily consist of documents relating to her educational career inclusive of materials from her graduate studies as well as her professional pursuits as a college professor and chairperson of the Environment Science Department within the University of the District of Columbia. The collection also retains Berryman's writings which range from poetry to scientific writings, the foremost being the manuscript and printed editions of the textbook she authored entitled, Science of Man's Environment- Principles of Science and Technology for Environment, Marine, Engineering, and Ocean Science Technology, published in 1986. The collection also records Berryman's active involvement within various professional and religious organizations which include the National Association of Black Women Attorney's and Shiloh Baptist Church of Washington, DC. Berryman's immediate family, her daughter's Dr. Sherrill Berryman Johnson (professor, choreographer, dancer, scholar) and D'Michelle Berryman (engineer, attorney and creative writer) are documented within the collection through correspondence, writings and photographs among other materials. Dr. Berryman Johnson's collection is also held within the Manuscripts Division of Moorland Spingarn Research Center.

Berryman was born in Darlington Heights, Prince Edward County Virginia to Mary and Charles Spencer the 5th of 9 children. She was chosen by her parents and siblings to be the person whom they would all support financially and otherwise in her quest for education and advancement. Many waived their own education to support Berryman's aspirations. With that affirmation, Berryman as educator, attorney went on to hold various positions of historic note in the fields of environmental science and law. Some of these positions included Physical Oceanographer and Instructor within United States Naval Oceanographic and Chairman of the Environmental Science Department and Professor of Marine Biology, University of the District of Columbia. As a major advocate of education, Berryman received various appointments including serving as the Physical Science Administrator for the National Council on Marine Research and Development. Through this appointment she served on an Ad Hoc Committee organized to develop job opportunities for minorities within Marine Science and Oceanography. In 1974, her advocacy for science education enabled Berryman to successfully write and received a \$208,000, Sea Grant to established and implement the Marine Science Technology program at Washington Technical Institute (WTI) (later became a part of the University of the District of Columbia (UDC)). Berryman desire to establish this program is documented within the collection series Teaching Materials, specifically within the WTI file entitled "Developing Material" which contains Berryman's writings on the Marine Advisory Programs, noting the proposals which led to the formation of the Marine Science programs which became a part of the Environmental Science Deportment at UDC. Berryman's continued impact on the marine science field was evident through her reputation in the profession, even internationally. An example of this is located within the Correspondence Series as described in a letter from Chao Maoxiang, a graduate of Shandong College of Oceanology in China, expressing his interest in her research.

Scope Note

In the field of law Berryman used the study of law and the judicial system to support her advocacy for the environment. In 1975, she established a legal practice in Civil, Environmental and Marine Law. Within the academy she established a curriculum for the teaching of Environmental Law to now-law majors in science and technology. She also aligned herself with other law academics, to train law students in the strategies of passing the bar. Utilizing a seminar entitled PTB (Passing the Bar) Testing Techniques Attorney's Berryman, Everett Bellamy, Alphonso Gaskins and Cassandra Sneed Ogden (who later founded the Council on Legal Education Opportunity (CLEO)) educated students on the best techniques to prepare for the bar exam. Although passionate about about science and law, Berryman's spiritually and love for her daughters and family out weighted her academic talents.

Berryman's dedication to her spiritual practices was demonstrated through the various positions she held at Shiloh Baptist Church. Berryman served on the Board of Trustees, the Senior Choir and the Inspirational Praise Choir among many other duties. Her late daughter's accomplishments were truly as testament to her dedication as a mother and consistent advocate for education. D'Michele Berryman was an engineer and attorney would also worked with professionals in the marine science fields as well as an attorney representing noted historical figures. As previously stated her eldest daughter Dr. Sherrill Berryman-Johnson was a research scholar, dance artist and educator. In 1992, Dr. Johnson played a pivotal role in successfully convincing the Howard University Board of Trustees to establish a dance major, making Howard University the first and only Historically Black College and University (HBCU). Until 2013 Howard University was the only HBCU to offered a Bachelor of Fine Arts in Dance. Berryman Johnson served as the Coordinator of the Dance Major Program from 1992 until she passed in 2010.

Attorney Matilene Spencer Berryman was the living embodiment of progress as documented through her many accomplishments. Her collection is a rich research resource for those interested in the sciences, law, education and a spirit of dedication.

Series A Box 224-1	Personal Papers This series contains material documenting Berryman's personal life and career. Dates range from 1964-2000. The records in this series include biographical information such as obituaries, greeting cards from her daughters, calendars and appointment agendas. This series also includes documents relating to the death of her youngest daughter, D'Michelle.	
Series B Box 224-1	Family Papers The Family Papers series includes papers primarily documenting the lives of Berryman's daughters. These files are divided into two subseries: Dr. Sherrill Berryman Johnson and D'Michelle Berryman. Files contain greeting cards, post cards, and dance arts performance programs as Dr. Berryman Johnson served as the Coordinator of the Dance Major Program at Howard University. Within the sub series are also news clippings, advertisements, and a college year book from D'Michelle's matriculation at North Carolina A&T University. Other professional materials include documents relating to D'Michelle's career as an attorney, one of which documents a legal case of Onwin Primus Borde (son of Dr. Pearl Primus), who was a client of D'Michelle.	
Series C Box 224-2	Correspondence This small series primarily includes professional correspondence received and generated by Berryman. Although the series is arranged alphabetically, persons of note are listed separately. Due to its administrative content, correspondence specifically relating to her career/work at The Washington Technical Institute and University of District of Columbia can also be found in the Teaching Materials Series.	
Series D Box 224 -2- 3	Education This series documents materials that reflect Berryman's academic matriculation in programs she received degrees in, as well as continuing education workshops/seminars. The series is divided into seven subseries: Pennsylvania State University, University of California (Los Angeles), Howard University (Doctoral Program and Law School), The George Washington University, University of Rhode Island (Masters of Marine Science) and continuing education courses.

Series E Box 224 -4-8	Teaching Materials The files included within this series document Berryman's career as instructor and college professor teaching various courses including oceanography, marine and environmental sciences. This series is composed of four subseries: The United State Naval Oceanographic Office, Washington Technical Institute (WTI) and University of District of Columbia (UDC), Reference Files (Non institution specific). Files contain course materials for physical oceanography, marine science, environmental law and environmental science Among the materials are handouts, tests and quizzes, logs, data, transparencies and research findings. Specifically within the WTI files is a document entitled "Developing Material" which contains Berryman's writings on the Marine Advisory Programs. The content of this file relates the foundation for the establishment of a Marine Science Program at WTI. Berryman wrote and received a federally funded \$208,000 Sea Grant supporting the implementation of the Marine Science Technology program at WTI. This series also includes documents noting the drafting and receipt of the grant. Therefore, the WTI and UDC file are arranged reflecting the development of the marine and environmental science programs.
Series F Box 224 -8	Law Practice (RESTRICTED CASE FILES) This series contains materials which document Berryman's career as an attorney in her independent law practice. Although this series is small, it reflects a variety of cases for which she served as the attorney. This series also includes two sub series case files and operations.
Series G Box 224 -8	Market Place of Idea's, Inc. The files making up this small series document Berryman's incorporated business Market Place of Idea's, Inc. She utilized the company to market/promote and distribute her text book Science of Man's Environment: An Introduction to Environment and Marine Science. Market Place of Idea's Inc. was also utilized to promote workshops/seminars using the text book.

The largest section of this series documents Berryman's association within Shiloh Baptist Church,Washington D.C.
Series I Box 224 -11-13	 Writings This series is divided into six subseries, the largest of which is writings related to the text book authored by Berryman entitled, <i>Science and Man's Environment</i>- Principles of Science and Technology for Environmental, Marine, Engineering and Ocean Science Technology, which includes drafts and manuscript versions of the book. The six subseries include: Speeches (include religious based subject matter), Articles, Manuscripts (unpublished works, articles, teaching materials), Notes and Research Files (publications not necessarily authored by Berryman). The research files also reflect the correlation of materials utilized over many years by Berryman which assisted in the writing of the text book.
Series J Box 224 -14-17	Printed Materials The content of this series is organized into three subseries. The first series is Science and Man's Environment which contains published copies of Berryman's textbook <i>Science and Man's Environment</i> - Principles of Science and Technology for Environmental, Marine, Engineering and Ocean Science Technology and a monograph entitled <i>Impact of Man on the Environment</i> (Pollution and Radiation). The second subseries is Market Place, Inc. includes business cards, booklets and brochures used in the promotion of educational and law firm related activities. The third sub series is entitled Field of Interest which reflects documents relating to her fields of study in law and science (i.e. sea and ocean) and history (i.e. black history). Therefore, some of the materials include news clippings and research documents. This series also contains a publication entitled <i>Science Anytime:</i> Contribution of African American Scientists in which Berryman is identified as one of the featured scientists.
