#### New Board Chairman



The Howard University Board of Trustees has elected Wayman F. Smith III, as its chairman. Smith, whose tenure became effective on July 1, 1991, is vice president for corporate affairs at Anheuser-Busch Cos., Inc. He replaces John E. Jacob, board chairman since July 1, 1988 and a trustee for 20 years.

Smith, who graduated from Howard's School of Law in 1965, has held his present corporate position since 1980. Also, he serves on the board of directors of the St. Louis-based company. He became a Howard trustee in 1989.

His predecessor, Jacob, is president and chief executive officer of the National Urban League. He is a Howard graduate, with a Bachelor of Arts degree in economics and political science (1957) and a Master of Social Work degree (1963).
