

- 1. The usage of personal phones/cameras are not permitted.
- 2. Researchers are required to sign this form which serves as the *FOR RESEACH ONLY DISCLAIMER FORM* prior to usage of photography equipment, as this service is provided for research purposes only.
- 3. All donors of manuscript collections to the Center have not transferred literary rights. Therefore, permission to use these collections for research does not include permission to publish excerpts. It is the researchers' responsibility to obtain permission for any eventual publication from the holders of literary rights.
- 4. Photography duplications may be denied due to the condition of the material, the need to protect copyright, or because of other considerations pertaining to the material in use. *Photographing unpublished manuscripts is limited to 25%*.
- 5. Photography duplication of photographs is not permitted.
- 6. Staff will instruct patrons on how to handle and create photographs of documents. Please do not alter the camera settings.
- 7. Researchers are required to complete a photography request form as they create research only photographs. Request will be delivered electronically to the researcher.
- 8. Photographs of documents are \$.10 per page, up to 25 pages. Additional copies are \$.50 each after the first 25 pages. The payment for photographed document(s) *does not constitute the purchase of the materials or their contents*.
- 9. Photographs are not to be transferred to third parties or other institutions.
